#### **Notice Regarding Approval of New Listing for GMS Group Co., Ltd.**

Nissei Plastic Industrial Co., Ltd. (hereinafter referred to as "Nissei Plastic Industrial") and TOYO INOVEX Co., Ltd. (hereinafter referred to as "TOYO INOVEX"; collectively, Nissei Plastics and TOYO INOVEX are referred to as "the Companies") announced on November 14, 2025, in the "Notice Regarding the Execution of a Management Integration Agreement for the Management Integration of Nissei Plastics Co., Ltd. and TOYO INOVEX Co., Ltd. through the Establishment of a Joint Holding Company (Stock Transfer)", and will establish GMS Group Co., Ltd. (hereinafter referred to as "GMS Group") as the wholly-owning parent company of both companies through a joint share transfer method, effective April 1, 2026.

Today, the Tokyo Stock Exchange approved the new listing of GMS Group on its Prime Market. Details are provided below. With the establishment of GMS Group, both companies will become wholly-owned subsidiaries of GMS Group and are scheduled to be delisted on March 30, 2026.
